IFM in Great Britain (ITSO Standard)

Systems on basis of the standard

Situation as of 01.04.2008:

All new „concession passes“ (cp) are issued on ITSO Cards.

At present the issue of ca. 3,6 Mio ITSO Cards in various Counties and Cities is planned until end 2008 – mainly for cp but also for other products.

BUT : even though the national standard exists there is no full interoperability between England and Scotland.

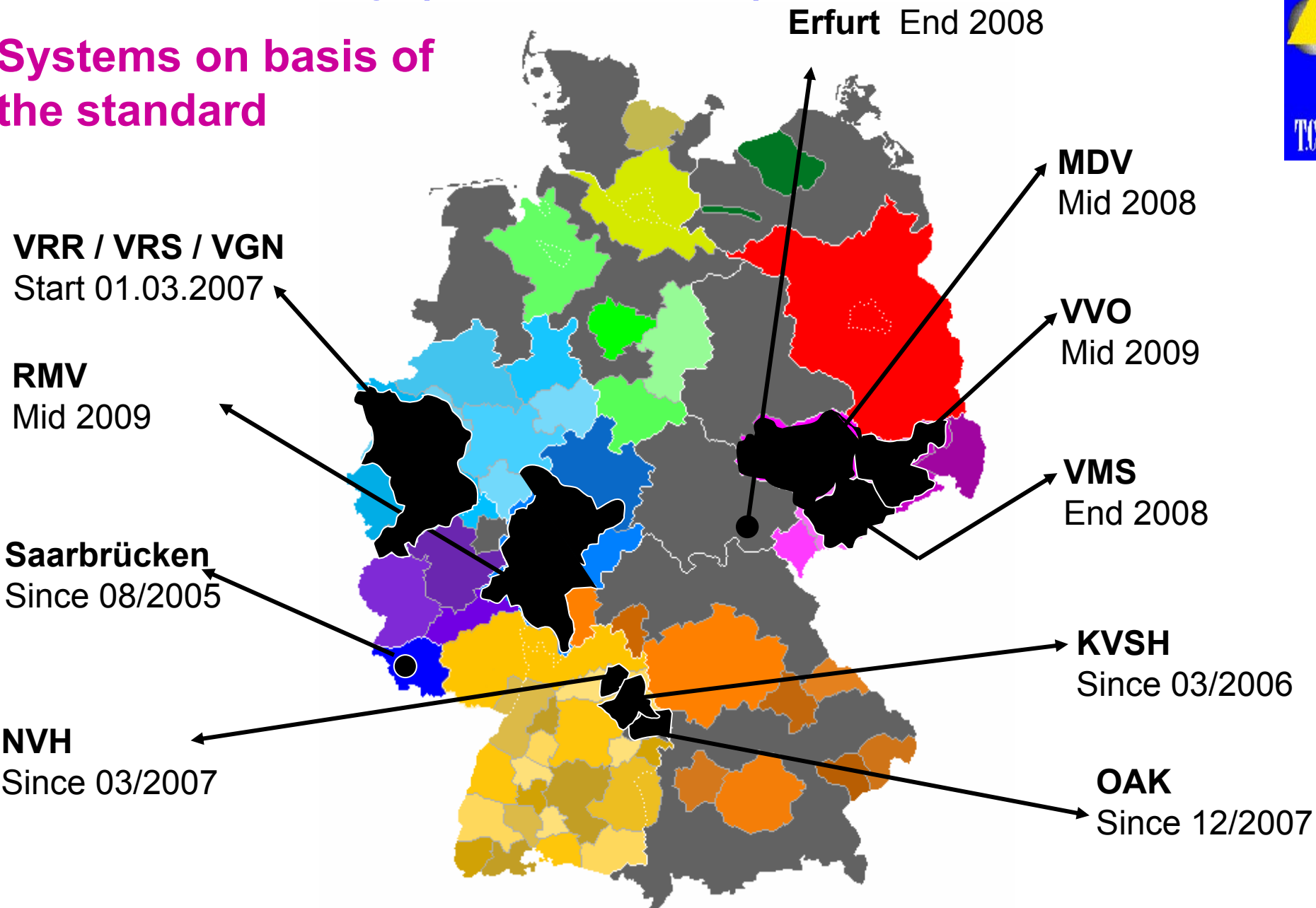

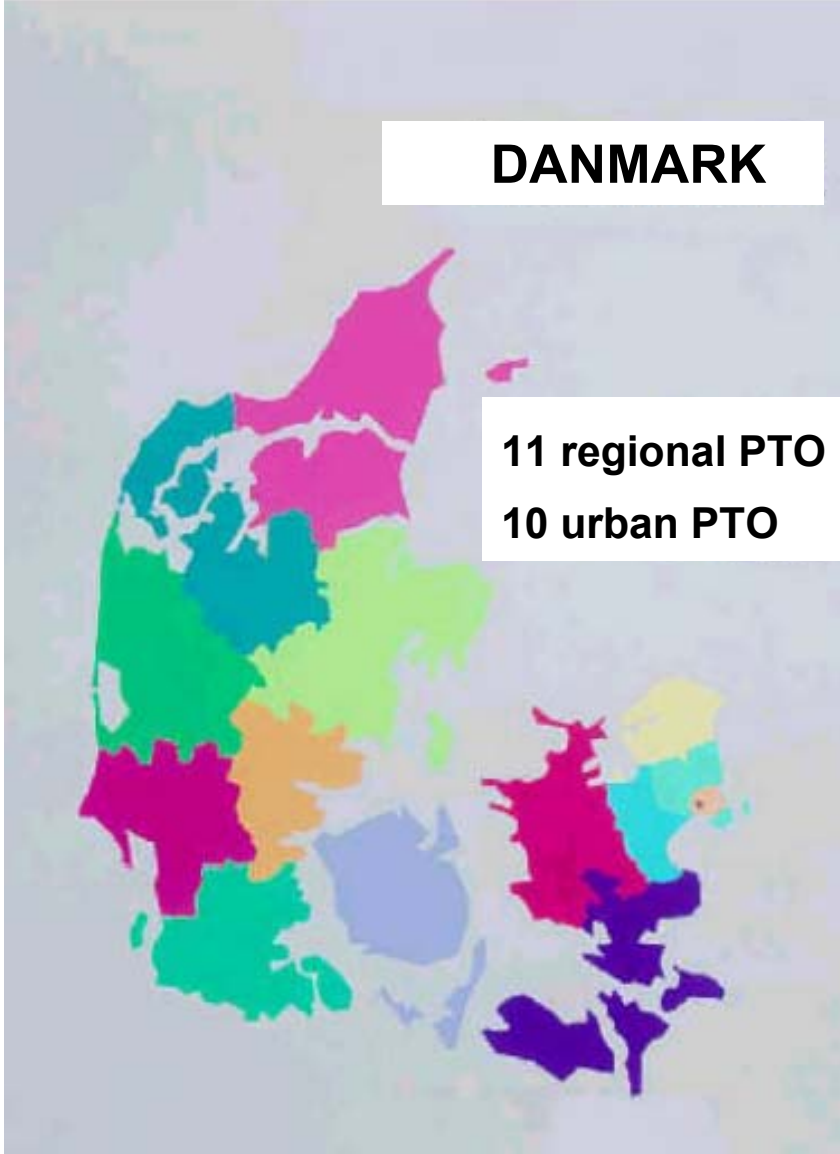

9 provinces with 11 big PTOs create 1 tariff system and 1 IFM-System (**STIMER**) as a regional standard and thus guarantee regional interoperability

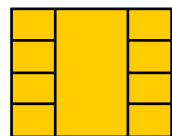
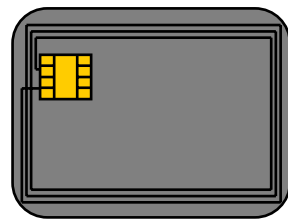

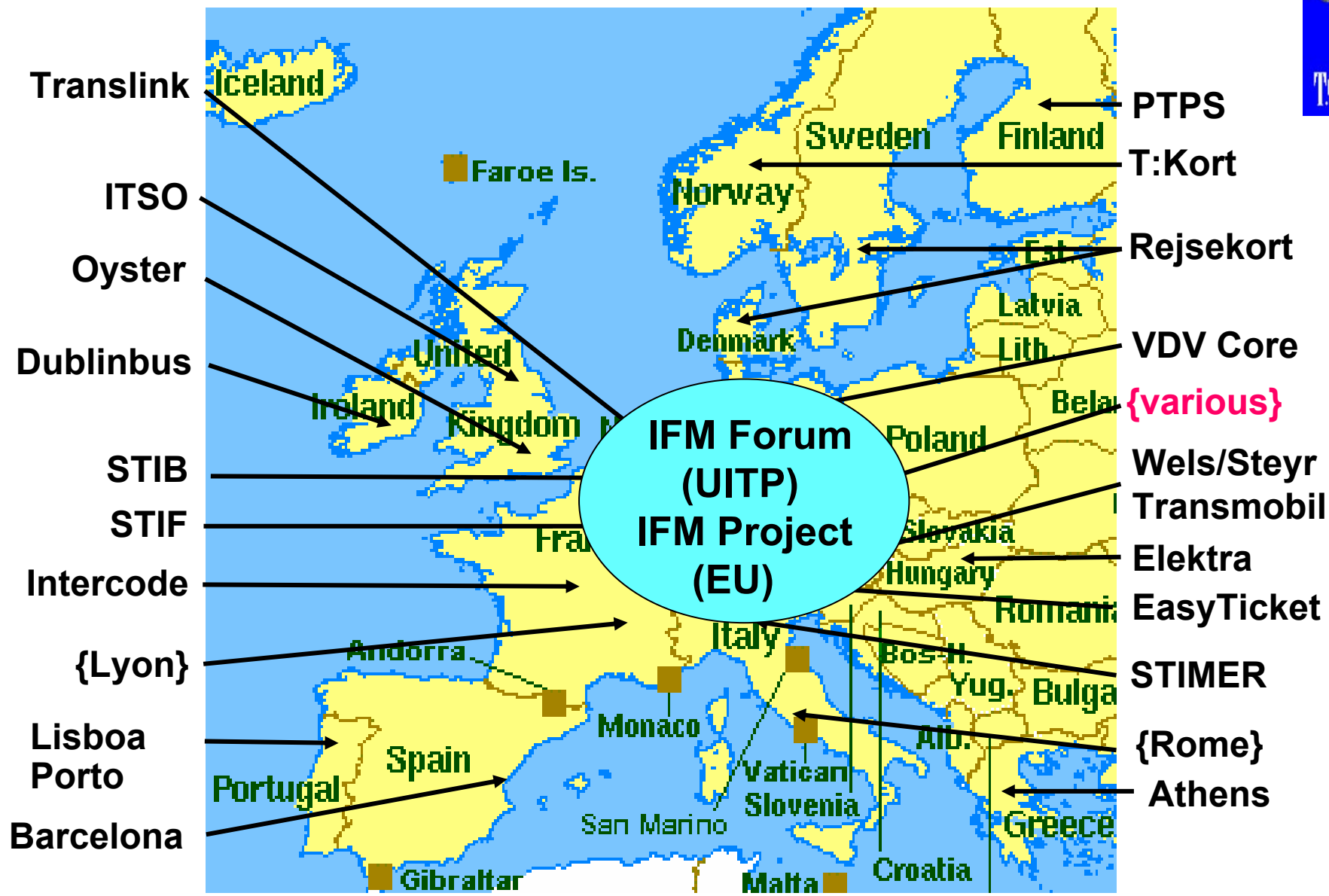
